"Participation !! Both current detachments that will be turning in their charters are a direct cause of participation. When we have members who are just an annual fee, we should ask ourselves why.

Why are they not invested into the MCL? Why are they not at meetings? Why are they not on Staff? Why are they not at events?

When they are not involved, they will not get involved unless we take action. Are we staying in touch, are we willing to mentor and give direction. Are we asking them to take a leadership role no matter how small the role is? Delegate responsibilities! When we don't do this, the Participation dwindles away. Eventually the detachment will too. Consider how our detachments can overcome this obstacle. Look to our busy and motivated

Detachments and ask them what they do to get and keep members engaged."
